

Butterfield Launches Charitable Trust Fund and Opens for Applications

St. Peter Port, Guernsey & St. Helier, Jersey –19 February 2025: Butterfield has established a charitable trust with the aim of providing funding grants to local registered charities and non-profit organisations for special projects and programmes that significantly benefit people in Guernsey and Jersey.



The Butterfield Charitable Trust– Channel Islands, which is now accepting applications until 25 April 2025, will prioritise projects focused on protecting the environment, supporting the community and promoting a more inclusive society.

Local registered charities and non-profits can apply for funding through the Major Grant programme, which opens once a year and awards amounts of £10,000 or more, including multi-year grants, or the Small Grant programme, which is open through-out the year and awards amounts of £10,000 or less.

Richard Saunders, Butterfield’s Managing Director, Channel Islands & UK, said, “Supporting the long-term well-being of our local communities is something we are committed to doing. The Butterfield Charitable Trust– Channel Islands is aligned to our overall sustainability framework, and is a fantastic opportunity for those working to enrich the lives of people in our community to get the funding they need to continue their efforts and leave a lasting impact. We encourage anyone who is eligible to apply before the deadline.”

All applications will be reviewed by the Butterfield Charitable Trust – Channel Islands Committee and assessed according to key criteria, including the ability to measure outcomes and impact, to ensure a fair process. Applicants will be notified of the committee’s decision via email by 15 May 2025.
